## AN ORDINANCE SETTING FORTH FIRE INSPECTION FEES AS PER N.J.A.C.5:71-2.3

WHEREAS, the Common Council of the City of Beverly has received a Resolution (\#2017-0701) from the Board of Fire Commissioners authorizing a revision of fee/permit schedules; and

WHEREAS, the Board of Fire Commissioners have requested the City adopt an Ordinance setting forth the fees/permits.

NOW, THEREFORE BE IT ORDAINED by the Common Council of the City of Beverly, County of Burlington, State of New Jersey "SCHEDULE OF FIRE INSPECTION FEES" by the following provisions:

1. Fifty dollars (\$50) Inspection fee if notification and request for Inspection is received at least ten (10) working days prior to Settlement Date
2. One hundred dollars ( $\$ 100$ ) Inspection Fee if notification and request for inspection is received less than ten (10) working days prior to settlement date.
3. Fifty dollars ( $\$ 50$ ) additional fee if a re-inspection is necessary to receive full compliance.
