WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 19, 2022 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2023 and ending December 31, 2023 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

The proposed 2023 Annual Budget increased \$23,885.00 above 2022. The Fire District will complete the second and final year of a FEMA SAFER Grant award in 2023. The amount raised by taxation increased by \$11,677.00. or 5.4%.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

Excluding budget items related to SAFER grant expenditures, interest on investments increased by \$1,000 given that investment interest rates have increased. Like many government agencies and private entities, the Fire District experienced unprecedented increases in the cost of goods and services attributed to the highest levels of inflation not seen in decades. Many 2023 appropriation line items have year over year increases above 10% because of inflation and the limited availability of parts, rising fuel and utility costs, increased wage costs and shortages of goods and services.

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The amount raised by taxation increased by \$11,677.00. or 5.4%. The Unrestricted Fund Balance is unchanged year to year. The 2023 Annual Budget is in compliance with the 2% Property Tax Levy Cap utilizing cap bank from 2021 of \$55.00 and from 2022 of \$14,932.00.
