Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 16, 2024 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2025 and ending December 31, 2025 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on January 13, 2025.

The proposed 2025 Annual Budget increased \$1,100.00 over 2024. The amount raised by taxation increases \$5,622.00. The fire tax rate is estimated to increase \$0.003 cents. Beverly City Fire District provides fire service to Edgewater Park Township Fire District (EPT) through an inter-local shared services agreement. The current agreement was signed in 2003 and extended six times, the last extension was agreed to in 2023. Beverly had anticipated a 3% increase (\$9,522) in 2024 revenue from EPT but unfortunately the parties were unable to reach an agreement. Consequently, outside service revenues are expected to remain the same in 2025 as in 2023 and 2024 at \$317,408.00.

Overall Total Other Operations Expenses decreased (25,700.00) -9.2%. As in the previous year, in order to recruit and retain firefighters the District has allocated appropriations in its budget to compensate the fire chief and provide firefighters an hourly stipend and incentives to work duty crews contributing volunteer time. The budgeted duty crew stipend was increased \$6,000. The District also continues to provide funding to its merit-point based Volunteer Incentive Program. As required, the Volunteer Incentives (\$15,000) are budgeted in Operation Salaries & Wages with appropriate federal tax withholding as fringe benefits. Advertising decreased (200.00) -28.6% due lower need. / Professional Services decreased (\$5,000) 20% reduced need. / Apparatus – Contract PM increased 3,500.00 53.8% due to higher servicing costs of aging and increased usage of apparatus. / Fire Hydrant Service increased \$5,000 10% due to rising utility costs. / Facilities Repair & Maintenance decreased (15,000.00) -50.0% due to deferring repairs & maintenance. / Fuel (Vehicles) decreased (2,000.00) -18.2% due to expected lower and stable fuel prices. / Operating Material & Supplies increased 1,500.00 60.0% due to to expected usage. / Training increased 3,000.00 42.9% to meet increased requirements and maintain readiness.

The District is utilizing \$60,000.00 or \$5,000.00 more of its Unrestricted Fund Balance than in 2024. The 2025 Annual Budget is in compliance with the 2% Property Tax Levy Cap.
