The Beverly City Fire District No. 1 reached an agreement with Edgewater Park Fire District No. 1 to extend its 2003 intra-local fire services agreement retro-active from January 1, 2025 thru December 31, 2027 for which EPFD agrees to increase its compensation to BCFD for operating expenses and provide contributions for new capital expenditures. The amount to be raised by taxation decreases from the prior year by \$12,174.00 resulting in a nominal decrease in the fire tax rate for 2026.

The cost for certification and testing on apparatus and pertinent fire equipment are higher (18.52%) than previous year due to inflationary reasons. We are decreasing our expenditures on Communications and Maintenance due to reduced need. The cost for purchasing fuel is expected to be lower (11%) due to current lower and stabilized fuel costs. The cost of Non-bondable equipment is planned to be higher (18.18%) due to the need to replace older and worn-out equipment. The cost of Non-Bondable Turn-out Gear is higher (50%) in order to replace older turnout gear and acquire turnout -gear for new members. We are increasing our Training expenditures (40%) in order to improve the capabilities of our firefighters. We are also increasing (66.67%) our expenditures on Uniforms to accommodate new members and to replace worn-out uniforms. In addition, we propose to increase our Reserve for Future Capital Expenditures by 200% in order to be prepared for the planned replacement of an older fire engine and renovations to a fire station. Overall, our proposed total costs for operations will increase 7.69% and the total cost for all appropriations will increase only 3.15% that is comparable with overall current inflation estimates.
